

STATEMENT OF PROBABLE CAUSE:  
AFTER AN EXTENSIVE SEARCH FOR A MISSING SEVEN YEAR OLD FEMALE, SHE WAS LOCATED  
DECEASED IN THE BASEMENT OF THE ARRESTEE'S RESIDENCE. ARRESTEE WAS  
INTERVIEWED AND, POST-MIRANDA ADMITTED TO ATTEMPTING TO CONFINED THE VICTIM TO  
THE RESIDENCE BY FORCE, RESULTING IN HER DEATH. ARRESTEE ALSO ADMITTED TO  
ATTEMPTING TO CONCEAL THE BODY AND OTHER FORENSIC EVIDENCE.
